After review of the results, there being no objections, and being otherwise sufficiently advised, the Board ratifies the results of the card check by a vote of 3-0.

## Amended Certification of Representation

The undersigned hereby certifies that the Classified School Employees Council-Las Cruces (CSEC-LC) #4994 (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.38 to compel amendment of the certification of the bargaining unit issued by this office on November 5, 2021 (PELRB 308-18) with regard to the following bargaining unit comprised of Las Cruces Public Schools employees:

Educational Assistants, Custodians, Nutritional Services, Nutrition Services Warehouse Employees, Campus Security, Stadium Supervisor, Physical Plant Department Employees, Classified Library Personnel (Associate Librarians and Assistant Librarians), Materials Management employees, Secretarial/Clerical employees in salary schedule levels I-IV, Computer Technician Level 2, District Computer Technician Level 1, District Computer Technician Level 2, District Instructional Technology Support Technician Level 2, and LCPS TV Operations Manager.

The undersigned makes this certification based on the following:

- 1. By a Clarification Petition filed **October 28, 2021** the Union requested accretion of the positions described below into the above-described unit.
- 2. On **October 28**, **2021** the Board's Executive Director determined that the Petition was facially valid and sent notice to the Union and to the County requesting a statement of their positions no later than **November 12**, **2021** as to whether the amendment should be made. The Las Cruces Public Schools had no objection to the accretion as requested.
- 3. The Petition does not raise a question concerning representation and it presents sufficient facts to show that the positions should be accreted and an amendment to the certification should be made. Accordingly, certification of the bargaining unit issued by this office on **November 5, 2021** shall be, and hereby is, amended to accrete the positions of "Translators/Interpreters, English Learner, Bilingual Programs, Parent Outreach workers, Data Analysts, Family and Community Support Specialists, Student/Parent/Family Facilitators, Nutrition Services Specialists and Nutrition Services Specialist Produce" into the bargaining unit.
