Certification of Representation

The undersigned hereby certifies that Communication Workers of America (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.37 to clarify the bargaining unit comprised of employees of the State of New Mexico Early Childhood Education and Care Department to reflect the current job classification titles that have changed since the original certification of a different unit including those positions. The resulting certified unit is described as follows:

Educational Administrators, B9039 (within School Based Pre-K division only); Medical Secretaries, R6013 (within FF Program only); Management Analysts, C1111 (within FF Program only); Office Clerks, General, R9061 (within FF Program only): Registered Nurses, K1111 (within FF Program only); Secretaries, Except Legal, Medical, And Executive, R6014 (within FF and FIT Programs only); Social & Community Service Coordinators, B9151 (within FIT Program only)

The undersigned makes this certification based on the following:

- A bargaining unit represented by CWA at PED was originally certified on 1. December 13, 2004 that included the aforementioned positions. After ECECD was created as a distinct agency, PED employees as described above were assigned to it without disputing their CWA-covered status.
- 2. By a Joint Petition for Unit Clarification filed January 10, 2023 the parties iointly requested clarification of the prior Certification of the Exclusive Representative with regard to the employees of the above-described unit.
- On January 10, 2023 the Board's Executive Director determined that the 3. Petition was facially valid.
- The Petition does not raise a question concerning representation and it 4. presents sufficient facts to show that this certification should issue.
