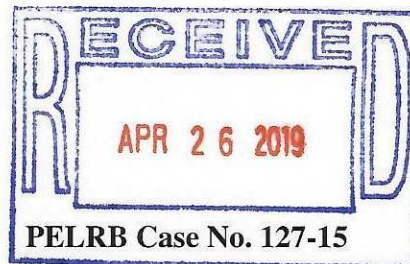

SETTLEMENT AGREEMENT

THIS SETTLEMENT AGREEMENT (the "Agreement") is made between the State of New Mexico ("Employer") and the Communications Workers of America, AFL-CIO ("CWA").

RECITALS


WHEREAS, CWA filed Prohibited Practice Charge No. 127-15 with the New Mexico Public Employees Labor Relations Board ("PELRB");

NOW, THEREFORE, in consideration of the mutual promises and undertakings set forth below, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:


AGREEMENT

1. The Parties in the interest of closure and the mutual resolution of their differences seek to enter into this Agreement.
2. The Employer agrees to recommence negotiations with CWA for purposes of reaching a new collective bargaining agreement. The initial bargaining demand by CWA shall be made no later than May 31, 2019.
3. The parties agree to start bargaining from the point of the current collective bargaining agreement, and that neither party shall rely on or be required to respond to proposals made in previous attempts to reach a new collective bargaining agreement.
4. CWA agrees to withdraw Prohibited Practice Charge No. 127-15 following the execution of this Agreement.
