## **Amended Certification of Representation**

The undersigned hereby certifies that **Peñasco Federation of United School Employees**, **AFT-NM Local 4285**, (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.35 to compel amendment of the certification of the bargaining unit as an incumbent bargaining unit issued by this office on **June 4**, **2007** with regard to a bargaining unit comprised of **Certified Teachers** employed by the **Peñasco Independent School District**, to accrete into that unit the position of **MS/HS Counselor**.

The undersigned makes this certification based on the following:
