ORDER

THIS MATTER came before the Public Employee Labor Relations Board (“Board”) at its regularly scheduled meeting on August 2, 2022 to affirm the issuance of an Amended Certification of Representation in *Rio Rancho School Employees Union and Rio Rancho Public School District*, PELRB 309-22 accreting Instructional Coordinators and Instructional Coaches into an existing bargaining unit comprised of employees of the District. After hearing the Executive Director’s report and being otherwise sufficiently advised, a quorum of the Board members present voted 2-0 to affirm the issuance of the Amended Certification.

IT IS ORDERED that the Amended Certification of Representation issued on July 18, 2022 is affirmed.

Amended Certification of Representation

The undersigned hereby certifies that **Rio Rancho School Employees Union** (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.38 to amend the certification of an existing bargaining unit comprising employees of the **Rio Rancho Public School District** to accrete Instructional Coordinators and Instructional Coaches. The resulting certified unit is described as follows:

Regular Education K-12 Instructional Personnel, Special Education K-12 Instructional Personnel; Regular Education Pre-K Instructional Personnel; Special Education Pre-K Instructional Personnel; Educational Technicians/Specialists; Library Media Specialists; Nurses; Clerks; Library Media Specialists; Social Workers; Counselors; Rehab Counselors; Activities Coordinators; Speech and Language Pathologists; Diagnosticians; Occupational Therapists; Physical Therapists; Recreational Therapists; Psychologists; Audiologists; Custodial Helpers; Custodians; Maintenance Workers; Electricians; Electrician Apprentices; Plumbers; Plumber Apprentices; HVAC; Locksmiths; Ground Maintenance; Telecommunication/Alarm Tech.; Building Engineers; Custodial Foremen; Transportation Lead Bus Drivers; Educational Assistants; Bus Drivers; Health Aides/Assistants; Attendants; Workroom Aides/Assistants; ISS Aides/Assistants; Classroom Aides/Assistants; Cafeteria Workers; Library Aides/Assistants; Bookroom Clerks; Special Education Aides/Assistants; Special Services Tech.; ECE Aides/Assistants; Data Specialists; Ed. Tech. Aides; Behavior Intervention Specialists; ELL Aides/Assistants; Volunteer Coordinators; Family Resource Specialists; Pupil Advocacy Liaisons; Truancy Officers; Campus Security Aides; Computer Technicians; Attendance Officers; Secretarial Personnel; Receptionists; Secretaries; Bookkeepers; Registrars; Instructional Coordinators and Instructional Coaches.

The undersigned makes this certification based on the following:

1. By a Petition filed **July 7, 2022** the Union requested amendment of the Certification of the Exclusive Representative of the above-described unit.
2. On **July 8, 2022** the Board's Executive Director determined that the Petition was facially valid and sent notice to the Rio Rancho Public School District Board of Education and the Union requesting statements of their positions as to whether the amendment should be made no later than **July 22, 2022**. The Employer responded on **July 18, 2022** indicating that it had no objection to amendment of the Certification as petitioned for.

3. The Petition does not raise a question concerning representation and it presents sufficient facts to show that the amendment should be made. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect a change in the composition of the bargaining unit by the accretion of Instructional Coordinators and Instructional Coaches.
