


Dear parties:

### Amended Certification of Representation

The undersigned hereby certifies that **New Mexico Coalition of Public Safety Officers** (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.35 to compel amendment of the certification of the bargaining unit issued by this office on August 18, 2008 with regard to the following bargaining unit comprised of employees of the **Cibola County Regional Communications Center**:


**Dispatchers and Dispatch Supervisors, excluding supervisory, confidential, and probationary employees.**

The undersigned makes this certification based on the following:

1. By a Petition filed **December 9, 2013**, the Union requested amendment of the Certification of the Exclusive Representative of the above-described unit.
2. On **December 11, 2013** the Board's Executive Director determined that the Petition was facially valid and sent notice to CWA Local 7911 and to Cibola County requesting a statement of their positions no later than December 21, 2013 as to whether the amendment should be made. As of the date of this amendment no objection to the amendment has been received.
3. The Petition does not raise a question concerning representation and it presents sufficient facts to show that the amendment should be made. Accordingly, certification of the bargaining unit issued by this office on August 18, 2008 shall be, and hereby is, amended to reflect a change in the name of the recognized bargaining representative to "New Mexico Coalition of Public Safety Officers".
