

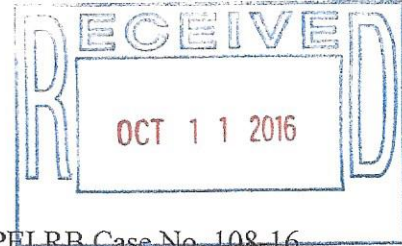

4. Based on the foregoing, the Respondent hereby requests a continuance of the hearing currently scheduled for October 11, 2016, concerning the Review of the Board's Order.


