**STIPULATED PETITION FOR
APPROVAL OF VOLUNTARY RECOGNITION**

COME NOW Petitioner AFSCME C-18 and Respondent Grant County Regional Dispatch Authority (GCRDA) and hereby moves the Public Employee Labor Relation Board ("PELRB") to approve Respondent's Voluntary Recognition. As grounds for approval, the parties state as follows:

1. On December 30, 2011, Petitioner filed a Petition for Initial Recognition of New Bargaining Unit.
2. The Petition for Initial Recognition was supported by a unanimous showing of support by the GCRDA of *Dispatcher, Telecommunications* of the petitioned-for bargaining unit.
3. On February 10, 2012 at the Initial Status Conference on the Petition for Initial Recognition of New Bargaining Unit.
4. The union filed then withdrew an amended petition including the Line Supervisor. The Parties agreed that the actual duties of the GCRDA Line Supervisor position was Supervisory AND NOT INCLUDED.
5. Respondent agreed that the *Dispatcher, Telecommunications* positions are appropriate for the GCRDA bargaining unit.
7. Upon resolution of the potential dispute, Petitioner and Respondent have no remaining issue regarding recognition of Petitioner as the employees' exclusive bargaining agent.

8. The time for an intervening labor organization has elapsed and no Petition to Intervene has been filed in this matter.

9. Respondent agrees that the majority of the appropriate members of the petitioned for bargaining unit desire to be represented by Petitioner.

10. Parties executed a Voluntary Recognition Form, attached hereto as Exhibit A.


WHEREFORE, the Parties respectfully request that the PELRB approve the Voluntary Recognition and vacate the scheduled Representation Hearing.
