CERTIFICATION OF UNITS

THIS MATTER comes before the Board on the Petition to accrete Alamogordo Public Schools' Student Nutrition Services staff into the existing classified employees bargaining unit represented by NEA-Alamogordo and to otherwise re-align existing bargaining units. The parties entered into a Memorandum of Understanding (MOU) dated 10-10-2011 made a part of, and incorporated into their Collective Bargaining Agreement. Based on that MOU, it is appropriate to accrete food service employees into the existing classified employees bargaining unit represented by NEA-Alamogordo and to modify the Certification of that bargaining unit to reflect the accretion. The parties also entered into a stipulated agreement dated 03-23-2012 further defining the bargaining units in question.

WHEREFORE, the NEA-NM represents the following two bargaining units in the Alamogordo Municipal School District:

1. A "classified bargaining unit" consisting of Educational Assistants, Computer Technicians, classified office personnel, maintenance staff, buildings and grounds staff, campus liaisons, nurse's assistants, library assistants, computer lab assistants, custodians, and Student Nutrition/ Food Service Staff and all other classified positions, excluding kitchen managers, contract 12

athletic personnel who are not otherwise employed by the District, temporary personnel, all classified substitutes and all administrative, management, supervisory and confidential personnel.

2. A "certified bargaining unit" consisting of speech language pathologists, speech language pathologist assistants, education diagnosticians, least restrictive environment specialist (LRE's), physical therapists, occupational therapists, certified occupational therapy assistants (COTA's) physical therapy assistants (PTA's), school psychologists, certified nurses, social workers, counselors, adaptive physical education teachers, instructional coaches or peer assisted learning mentors (PALM's), librarians, certified teachers, and all other certified positions excluding certified substitutes and all administrative, management, and supervisory personnel.

Notice is to be sent by the District to all employees affected by this certification and union dues or fair share as appropriate is to be paid within ninety (90) days from the date of this order.

This certification is issued on March 24, 2012 in Albuquerque, New Mexico.
