<u>ORDER</u>

THIS MATTER comes before the Public Employee Labor Relations Board on a Petition by NMCPSO for certification of the bargaining unit as the exclusive bargaining representative through voluntary recognition by Colfax County pursuant to 11.21.2.39 NMAC. The exclusive bargaining representation includes all non-probationary sworn and commissioned Sheriff's Department Deputies, Sergeants, Lieutenants and Captains employed by Colfax County and excludes probationary, confidential, supervisory and management employees from its representation.

At its regularly scheduled meeting on April 25, 2017, Director Griego provided the Board with the results of a card count conducted March 15, 2017 confirming sufficient support for voluntary recognition of NMCPSO as the exclusive representative for the bargaining unit described above. The Board being sufficiently advised votes 3-0 to:

- A. Ratify the results of the card count; and,
- B. Issue a Certification of Representation for the bargaining unit described above.

THEREFORE THE BOARD Orders Director Griego to publish this Order and issue Certification.

Certification of Representation

The undersigned hereby certifies that the New Mexico Coalition of Public Safety Officers (Union) has demonstrated a sufficient basis such that it should be recognized as the exclusive bargaining representative for those employees in the following bargaining unit comprised of employees of the Colfax County Sheriff's Department:

All non-probationary sworn and commissioned Sheriff's Department Deputies, Sergeants, Lieutenants and Captains employed by Colfax County, excluding probationary, confidential, supervisory and management employees

The undersigned makes this certification based on the following:

- By a Petition filed January 4, 2017 the Union informed Colfax County that it was prepared to demonstrate sufficient support among employees in the unit for its recognition as the exclusive collective bargaining representative for those employees.
- On January 9, 2017 the Board's Executive Director determined that the Petition
 was facially valid and that a preliminary review demonstrated a sufficient showing of
 interest to proceed toward an election.
- On February 21, 2017 the Employer provided a copy of a unit employee list. That
 list shows that there were seven employees in the unit thereby confirming the
 preliminary finding of sufficiency.
- 4. On March 10, 2017 the parties entered into a Voluntary Recognition Agreement memorialized by the Executive Director calling for a card count on March 15, 2017.
- 5. The card count took place as called for. Interest cards for eight employees were submitted and counted. However, three of those were successfully challenged leaving five valid interest cards, or 71% of the putative bargaining unit. Accordingly, after review by the PELRB at its April 4, 2017 meeting, the undersigned hereby certifies that the Union is certified as the exclusive bargaining representative for the unit described above.
