#### **CERTIFICATION OF BARGAINING UNIT**

The undersigned hereby certifies that the International Brotherhood of Teamsters, Local 492 (Union) has demonstrated majority support among the North Central Region Transit District (Department) employees in the unit described as follows:

Drivers and Dispatcher/Drivers whether employed full time or part time but excluding probationary, managerial, confidential, or supervisory employees as well as those designated as "Emergency Appointment", "limited term" or "Rider/Driver" employees as those terms are understood by the parties.

The undersigned makes this certification based on the following:

- 1. On February 27, 2012, the Union filed a Petition for Initial Certification of a New Bargaining Unit and notified the Department and the Public Employee Labor Relations Board that it was prepared to demonstrate majority support through the submission of signed membership/authorization cards from a majority of employees in the unit.
- 2. On March 20, 2012, the Department provided to the undersigned and to the Union a copy of a unit employee list. That list shows that there are 23 employees in the unit.
- 3. On February 27, 2012, the undersigned determined that the Union provided signed membership/authorization cards from 14 employees in the Unit.
- 4. On April 9, 2012, the parties entered into a Consent Election Agreement approved by the Executive Director and calling for an election May 8, 2012.
- 5. The election took place as called for in the Agreement followed by a card count at the NCRTD Compound on 331 N. Railroad Ave., Bldg. B, Española, NM at 3:00 p.m. The election results were 13 ballots cast in favor of the union out of a total of 16 ballots cast. More than 40% of the eligible voters cast ballots and a majority of the bargaining unit cast ballots in favor of representation by the union. Accordingly, the undersigned hereby certifies that the Union has demonstrated that it has majority support in the Unit.
