**THIS MATTER** comes before the Public Employee Labor Relations Board on a Petition by IAFF Local 4366, Santa Fe Fire Fighters Assoc. ("IAFF") for amended certification of the bargaining unit through a stipulated agreement with Santa Fe County to accrete non-probationary Shift Training Captains into the existing bargaining unit.

At its regularly scheduled meeting on April 25, 2017, Director Griego provided the Board with a Stipulation of Accretion signed by the parties. The Board being sufficiently advised finds by a vote of 3-0 to:

### Amended Certification of Representation

The undersigned hereby certifies that **Santa Fe County Firefighters Association/IAFF Local 4366** (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.35, NMAC 11.21.2.37 and 11.21.2.38 to compel amendment of the certification of the bargaining unit issued by this office on **January 18, 2005** with regard to non-probationary firefighters employed by Santa Fe County.


The undersigned makes this certification based on the following:

1. By an Amended Petition filed **December 8, 2016** the Union requested accretion of Captains into the above-referenced unit. The County filed its Amended Response objecting to the accretion on **January 9, 2017**.
2. A Hearing on the propriety of the petitioned-for unit was scheduled for **March 13 and 14, 2017**. However, on March 10, 2017, the parties settled their dispute over propriety of the unit which called for withdrawal of the Union's petition with regard to some of the Captain positions while the County agreed to accrete others.
3. Accordingly, the original 2005 certification of the bargaining unit issued by this office shall be, and hereby is, amended to reflect the accretion agreed to by the parties as follows:

**Shift Training Captains, Lieutenants, Firefighter/Paramedics, Fire Protection Specialists, Firefighter/EMTs.**
