### Amended Certification of Representation

The undersigned hereby certifies that **Santa Fe County Firefighters Association, Local 4366** (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.35 to compel amendment of the certification of the bargaining unit issued by this office on **January 18, 2005 (PELRB 332-04)** with regard to the following bargaining unit comprised of **Santa Fe County** employees:

**Firefighters/EMT Basic, EMT Intermediate, Paramedics, Lieutenants, Shift Training Captains, and Fire Protections Specialists I and II.**

The undersigned makes this certification based on the following:

1. By a Petition filed **March 25, 2021** the Union requested amendment of the Certification of the Exclusive Representative of the above-described unit.
2. On **March 25, 2021** the Board's Executive Director determined that the Petition was facially valid and sent notice to the Union and to the County requesting a statement of their positions no later than **April 8, 2021** as to whether the amendment should be made. The County had no objection to the amendment as requested.
3. The Petition does not raise a question concerning representation and it presents sufficient facts to show that the amendment should be made. Accordingly, certification of the bargaining unit issued by this office on **January 18, 2005** shall be, and hereby is, amended to accrete the position of "Engineer" into the bargaining unit.
