The undersigned hereby certifies that the parties, **AFSCME Council 18** and **Luna County** have demonstrated a sufficient basis pursuant to NMAC 11.21.2.35 to compel amendment of the certification of the bargaining unit issued by this office on **July 13, 2021** with regard to the following bargaining unit comprised of employees of **Luna County**:


Includes: Non-probationary security personnel (including Detention Officers, Corporals, Sergeants, Training Sergeants, and Lieutenants); administrative, Court Security Officers, Billing Specialists, and Records/Court Liaisons working at the Luna County Detention Center. Excludes: Probationary, confidential, supervisory, maintenance and management employees and support specialists.

The undersigned makes this certification based on the following:

1. By a Joint Petition filed **September 21, 2021**, the parties requested amendment of the Certification of the Exclusive Representative of the existing unit to that described above.
2. On **September 27, 2021** the Board's Executive Director determined that the Petition was facially valid following a telephone conference on that date and sent notice to the parties.
3. The Petition does not raise a question concerning representation and it, together with the parties' stipulation on file presents sufficient facts to show that the amendment should be made. Accordingly, certification of the bargaining unit issued by this office on **July 13, 2021** shall be, and hereby is, amended to reflect a change in the composition of the represented bargaining unit as set forth above.
