ORDER

THIS MATTER comes before the Public Employee Labor Relations Board on a Petition by Cibola County to Amend Certification of Representation of the Cibola County employee bargaining unit by the NMCPSO. The Board being sufficiently advised finds by a vote of 3-0 the following:

- Cibola County, with verbal approval by the NMCPSO representative, has a sufficient basis pursuant to NMAC 11.21.2.35 to remove certain positions from representation by the NMCPSO;
- Removal of certain positions from representation by NMCPSO reflects the
 fact that the Cibola County's Detention Center is closed and the positions
 formerly employed by the County at that facility, and included within the
 original 2014 certified bargaining unit, no longer exist.
- 3. Positions of Dispatchers and Dispatch Supervisors remain represented in the amended bargaining unit.

THEREFORE THE BOARD ratifies the Amended Certification of Representation.

Amended Certification of Representation

The undersigned hereby certifies that Cibola County has demonstrated a sufficient basis pursuant to NMAC 11.21.2.35 to compel further amendment of the amended certification of the bargaining unit issued by this office on January 10, 2014 with regard to the bargaining unit represented by the New Mexico Coalition of Public Safety Officers comprised of employees of Cibola County in the following positions:

Detention Line Officers, Detention Line Sergeants, Detention Booking Officers, Detention Transport Officers, Detention Transport Sergeants, Detention Officers-Front Desk Reception, Detention Medical Officers, Medical Secretaries, Medical Technicians, Medical Nurses and Records Clerks, excluding supervisory, confidential, and probationary employees.

The undersigned makes this certification based on the following:

 By a Petition filed April 25, 2018, the County requested amendment of the Certification of the above-described unit to reflect that the County has closed its Detention Facility and the represented County jobs no longer exist.

2. On May 7, 2018 the Board's Executive Director determined that the Petition was facially valid and sent notice to NMCPSO and to Cibola County requesting an Answer. NMCPSO timely responded and after conferring with the County, the parties notified the Director via email on June 8, 2018 that they resolved issues and the union withdrew any objection to the Petition.

The Petition does not raise a QCR requiring a hearing or dismissal and it presents sufficient facts to show that the amendment should be made as office on January 10, 2014 shall be, and hereby is, amended to reflect that the bargaining unit in Cibola County also represented by NMCPSO, Supervisors, excluding supervisory, confidential, and probationary employees.
