**ORDER**

**THIS MATTER** comes before the Public Employee Labor Relations Board at its regularly scheduled meeting on September 5, 2023 upon the parties' joint request filed June 28, 2023, to amend the Certification of the bargaining unit to reflect job title and classification changes since the original certification.

The Board finds and concludes that the Petition does not raise a question concerning representation and it presents sufficient facts to show that an amendment should be made. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect the current job classification titles as shown on the Executive Director's Amended Certification of Representation issued July 27, 2023. Upon review of the submissions and no one appearing in opposition to the Amended Certification, the Board by a vote of 3-0 hereby affirms and ratifies the Amended Certification of Representation issued by the Executive Director on July 27, 2023.


The undersigned makes this certification based on the following:

1. By a Petition filed June 28, 2023 the Union requested amendment of the Certification of the Exclusive Representative of the above-described unit to accrete the Tech Polysomnographic, Tech Polysomnographic Registered, and Tech Polysomnographic Trainee positions to the Unit Description.
2. On June 30, 2023 the Board's Executive Director determined that the Petition was facially valid and sent notice to the Union and University of New Mexico Hospitals, requesting a statement of their positions and a list of employees to be accreted no later than July 15, 2023 as to whether the amendment should be made. As of the date of this amendment no objection to the amendment has been received and the description of the unit herein has been agreed upon.
3. The Petition does not raise a question concerning representation and it presents sufficient facts to show that the amendment should be made. The number of employees in the group to be accreted is less than ten percent of the number of employees in the existing unit.
4. The petition is accompanied by a showing of interest demonstrating that no less than thirty percent of the employees in the group sought to be accreted wish to be represented by the exclusive representative as part of the existing unit and it would not constitute a separate appropriate bargaining unit.

Accordingly, certification of the bargaining unit issued by this office on June 16, 2006 as may have been amended from time-to-time thereafter, shall be, and hereby is, amended to reflect inclusion of Tech Polysomnographic, Tech Polysomnographic Registered, and Tech Polysomnographic Trainee positions.
