**STIPULATION OF DISMISSAL OF PROHIBITED PRACTICES COMPLAINT**

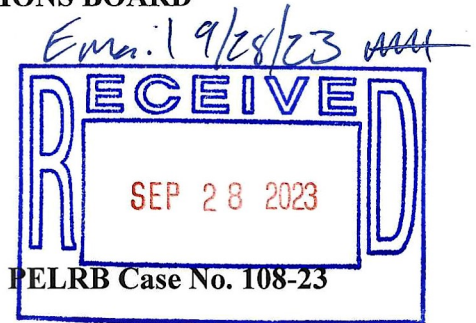
