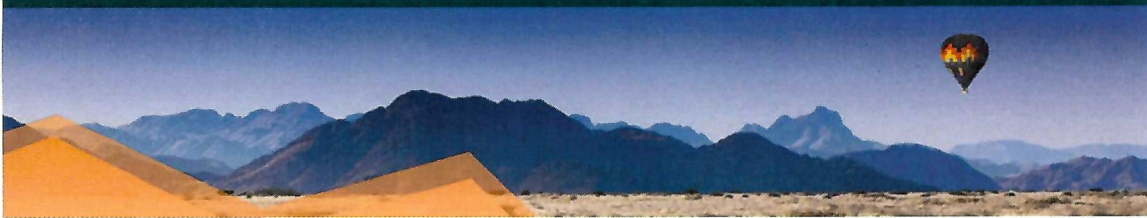

Amended Certification of Representation

The undersigned hereby certifies that AFSCME, Council 18 (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.37 to compel amendment of the certification of the bargaining unit established prior to 2005 to reflect changes to job titles and classifications in the bargaining unit comprised of employees of the New Mexico Corrections Department - Adult Prisons Division, as follows:

Behavioral Health Therapist II, HBHT23; Clergy, G2011; Correctional Officer, PCCO11; Correctional Officer – Sergeant, PCCO13; Correctional Officer – Lieutenant, PCCO15; Correctional Officer Specialist – Boiler Operations, PCSB15; Correctional Officer Specialist – Corrections Industries Programs, PCSC13; Correctional Officer Specialist – Electrician, PCSE15; Correctional Officer Specialist – Electronics, PCSN11; Correctional Officer Specialist – Fire, Safety and Sanitation Officer (FSSO), PCSF11; Correctional Officer Specialist – HVAC, PCSH15; Correctional Officer Specialist – K-9/Security Threat Intelligence Unit (STIU) Specialist, PCSK11; Correctional Officer Specialist – Locksmith, PCSL15; Correctional Officer Specialist – Maintenance, PCSA13; Correctional Officer Specialist – Mechanic, PCSM15; Correctional Officer Specialist – Plumber, PCSP15; Correctional Officer Specialist – Recreation, PCSR11; Correctional Officer Specialist – Special Programs, PCSO11; Correctional Officer Specialist – Wastewater, PCSU11; Correctional Officer Specialist – Warehouse/Canteen, PCSW11; Data Entry Keyers, R9021; Direct Care Level II, HNDC11; Financial Specialists, All Other, C2099; Information and Record Clerks, All Other, R4199; Library Technicians, I4031; Office and Administrative Support Workers, All Other, R9199; Office Clerks, General, R9061; Mental Health and Substance Abuse Social Worker, G1023; Probation Officers and Correctional Treatment Specialist, G1092; Secretaries, Except Legal, Medical, and Executive, R6014.

The undersigned makes this certification based on the following:

1. By a Petition filed October 20, 2023, the Union and the State Personnel Office jointly requested amendment of the Certification of the Exclusive Representative of the above-described unit.
2. On October 24, 2023, the Board's Executive Director determined that the Petition was facially valid and requested any information the parties may have to rebut his presumption that there were no questions of representation or other impediments to amendment. As of the date of this amendment no objection to the amendment has been received.

3. The Petition does not raise a question concerning representation and it presents sufficient facts to show that the amendment should be made. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect a change in the bargaining unit job titles and/or classifications
