

## Amended Certification of Representation

The undersigned hereby certifies that District 1199NM, National Union of Hospital and Health Care Employees (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.38 to compel amendment of the certification of the University of New Mexico Hospitals' Licensed and Technical bargaining unit to accrete the following job titles: Asst Cert Occupational Therapy Inpatient, Asst Physical Therapist Inpatient, Therapist Occupational Inpatient, Therapist Physical Inpatient.

The undersigned makes this certification based on the following:

1. By a Petition filed September 29, 2023, the Union requested accretion of the heretofore unrepresented positions referred to above.

2. Objections to the composition of the bargaining unit raised by the Employer on October 16, 2023 via email, were scheduled to be heard on November 14, 2023; however the parties resolved their dispute prior to hearing and it was vacated upon stipulation of the positions to be accreted on November 13, 2023.

3. The number of employees in the group to be accreted is less than 10% of the members of the existing unit so that the Petition does not raise a question concerning representation and it presents sufficient facts to show that the amendment should be made. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect accretion of the above-referenced job titles as shown on the attached Appendix A.
