
**ORDER** 

THIS MATTER comes before the Public Employee Labor Relations Board at its regularly scheduled meeting on January 9, 2024 upon the Joint Petition of the Parties to amend the certification for the New Mexico Children, Youth and Families Department to remove certain obsolete job titles from the certification, to modify certain job titles to be accurate, to add into the certification new positions which evolved from existing positions, and to accrete various job titles that have been treated as part of the bargaining unit by both parties despite not appearing on the prior existing certification. No unit composition or Questions Concerning Representation are at issue so, the Executive Director issued an Amended Certification on December 29, 2023. Upon review of the submissions and no one appearing in opposition to the Amended Certification, the Board by a vote of 3-0 hereby affirms and ratifies the Amended Certification of Representation issued by the Executive Director on December 29, 2023 including the findings appearing thereon.

## **Amended Certification of Representation**

1. By a Joint Petition filed November 9, 2023, the Union and the Employer requested amendment of the Certification of the Exclusive Representative of the above-described unit.

On November 11, 2023, the Board's Executive Director determined that the Petition was facially valid and requested any information the parties may have to rebut his presumption that there were no questions of representation or other impediments to amendment. As of the date of this amendment no objection to the amendment has been received.
- 3. The Petition does not raise a question concerning representation and it presents sufficient facts to show that the amendment should be made. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect changes in the above-referenced job titles and/or classifications.
