ORDER

THIS MATTER comes before the Board on a submission by the Utility Workers Union of America (“UWUA” or “Union”) disclaiming interest as the exclusive bargaining representative for a group of employees of the Village of Bosque Farms comprised of Utility Operators and Administrative Assistants employed by the Village of Bosque Farms. The Board, having reviewed the file and being otherwise sufficiently advised,

FINDS:

1. On December 22, 2023 this Board certified UWUA as the exclusive bargaining representative for Utility Operators and Administrative Assistants employed by the Village of Bosque Farms.
2. On February 12, 2025, UWUA sent notice to this Board that it was disclaiming all interest in continuing to serve as the exclusive bargaining representative for the unit described above.
4. Notice of the Disclaimer of Interest was publicly posted by the employer in the place where notices to employees are usually posted and no timely objections were received by the Board.

THEREFORE, the Board recognizes the Union’s disclaimer of interest as the collective bargaining representative effective February 12, 2025 and both parties are relieved of their bargaining obligations under the Public Employee Bargaining Act.

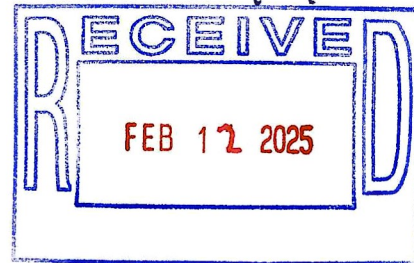
