ORDER

THIS MATTER came before the Public Employee Labor Relations Board at its regularly scheduled meeting on August 5, 2025, upon a Petition by the union to accrete the position of IT Project Manager II into an existing bargaining unit at the New Mexico Environment Department. The Director found no unit composition issues or Questions Concerning Representation and that the Petition was supported by an adequate showing of interest. Therefore, the Executive Director issued an Amended Certification on June 20, 2025 indicating the accretion of the aforementioned position. Upon review of the submissions and no one appearing in opposition to the Amended Certification, the Board, by unanimous vote, hereby affirms and ratifies the Amended Certification of Representation issued by the Executive Director on June 20, 2025 including the findings therein.

Amended Certification of Representation
