ORDER

THIS MATTER comes before the Public Employee Labor Relations Board at its regularly scheduled meeting on September 2, 2025, upon a Petition by the union to accrete the positions of all full-time and regular part-time teachers, early childhood into an existing bargaining unit at the University of New Mexico. The Director found no unit composition issues or Questions Concerning Representation and that the Petition was supported by an adequate showing of interest. Therefore, the Executive Director issued an Amended Certification on August 27, 2025 indicating the accretion of the petitioned-for positions. Upon review of the submissions and no one appearing in opposition to the Amended Certification, the Board, by unanimous vote, hereby affirms and ratifies the Amended Certification of Representation issued by the Executive Director on August 27, 2025 including the findings therein.

Amended Certification of Representation

The undersigned hereby certifies that **United Staff-UNM**, (Union or US-UNM) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.38 to compel amendment of the certification of the bargaining unit with regard to the **University of New Mexico** (Employer or University) employees represented by **US-UNM**.

The undersigned makes this certification based on the following:

- 1. The Union filed a Petition on June 16, 2025, 2025, (PELRB 319-25) requesting amendment of the Certification of the unit of Employer's employees represented by US-UNM. On June 17, 2025, the Board's Executive Director determined that the Petition was facially valid and sent notice of the Petition requesting each parties' statement of their positions. Neither party raised any objection to the accretion.
- 2. The Petition does not raise a question concerning representation and it presents sufficient facts that the amendment should be made. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect its current description as follows:

RESULTS OF CARD CHECK

On August 26, 2025, pursuant to NMAC 11.21.2.33, after resolving all unit composition issues and challenges to the validity of interest cards submitted by the union, and after the expiration of the intervention period, there being no intervention filed, I compared the union's showing of interest with the employee list provided by the employer. The following is the result of that comparison:

WHEREFORE, the showing of interest demonstrates majority support for US-UNM so that certification of its recognition as the exclusive representative of the unit in question shall issue.
