ORDER

THIS MATTER comes before the Public Employee Labor Relations Board at its regularly scheduled meeting on October 7, 2025, upon a Petition by the union to accrete the positions of Certified Medication Aide and Clinic Nurse into an existing bargaining unit at Santa Fe County. The Director found no unit composition issues or Questions Concerning Representation and that the Petition was supported by an adequate showing of interest. Therefore, the Executive Director issued an Amended Certification on September 19, 2025 indicating the accretion of the petitioned-for positions. Upon review of the submissions and no one appearing in opposition to the Amended Certification, the Board, by unanimous vote, hereby affirms and ratifies the Amended Certification of Representation issued by the Executive Director on September 19, 2025 including the findings therein.
