ORDER

THIS MATTER comes before the Public Employee Labor Relations Board at its regularly scheduled meeting on October 7, 2025, upon a Petition by the union to accrete the positions of Lead Transfer Station Attendant into an existing bargaining unit at the Estancia Valley Solid Waste Authority. The Director found no unit composition issues or Questions Concerning Representation and that the Petition was supported by an adequate showing of interest. Therefore, the Executive Director issued an Amended Certification on September 19, 2025 indicating the accretion of the petitioned-for positions. Upon review of the submissions and no one appearing in opposition to the Amended Certification, the Board, by unanimous vote, hereby affirms and ratifies the Amended Certification of Representation issued by the Executive Director on September 19, 2025 including the findings therein.

Amended Certification of Representation

The undersigned hereby certifies that **Teamsters, Local 492**, (Union) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.38 to compel amendment of the certification of the bargaining unit with regard to the **Estancia Valley Solid Waste Authority** employees represented by **Teamsters, Local 492**.

The undersigned makes this certification based on the following:

1. **Teamsters, Local 492**, filed a Petition on August 20, 2025, requesting amendment of the Certification of the unit of **Estancia Valley Solid Waste Authority** employees represented by **Teamsters, Local 492**. On August 21, 2025, the Board's Executive Director determined that the Petition was facially valid and sent notice of the Petition requesting each parties' statement of their positions. Neither party expressed any objections to the accretion
2. The Petition does not raise a question concerning representation and the petitioned-for employees share a community of interest with the employees in the existing unit, and whose inclusion in the existing unit would not render that unit inappropriate. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect its current description as follows:

Truck Drivers, Heavy Equipment Operators, Landfill Operators, Transfer Station Attendants, Mechanics, Scale Operators, Laborers and Lead Transfer Station Attendant

RESULTS OF CARD CHECK

On [DATE], pursuant to NMAC 11.21.2.33, after resolving all unit composition issues and challenges to the validity of interest cards submitted by the union, and after the expiration of the intervention period, there being no intervention filed, I compared the union's showing of interest with the employee list provided by the employer. The following is the result of that comparison:
