ORDER

THIS MATTER comes before the Board on a submission by the New Mexico Coalition of Public Safety Officers (“NMCP SO” or “Union”) disclaiming its interest as the exclusive bargaining representative for a group of Cibola County employees at the Cibola Regional Communications Center. The Board, having reviewed the file and being otherwise sufficiently advised,

FINDS:

1. On September 24, 2025, NMCP SO sent notice to this Board that it was disclaiming all interest in continuing to serve as the exclusive bargaining representative for the unit described above.
4. Notice of the Disclaimer of Interest was publicly posted in the place where notices to employees are usually posted and no objections were received by the Board.

THEREFORE, the Board recognizes the Union’s disclaimer of interest as the collective bargaining representative effective September 24, 2023 and both parties are relieved of their bargaining obligations under the Public Employee Bargaining Act.

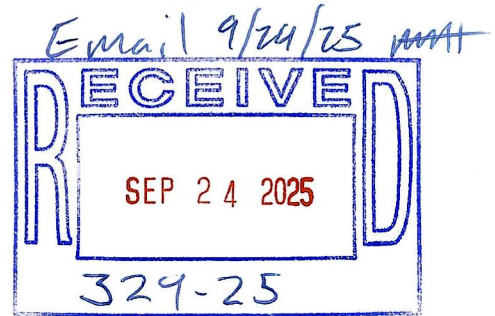
