THIS MATTER comes before the Public Employee Labor Relations Board at its regularly scheduled meeting on November 4, 2025, upon a Petition by the union to accrete all full- and part-time Parking Attendants into an existing bargaining unit at the University of New Mexico Hospital. The Director found no unit composition issues or Questions Concerning Representation and that the Petition was supported by an adequate showing of interest. Therefore, the Executive Director issued an Amended Certification on October 23, 2025 indicating the accretion of the petitioned-for positions. Upon review of the submissions and no one appearing in opposition to the Amended Certification, the Board, by unanimous vote, hereby affirms and ratifies the Amended Certification of Representation issued by the Executive Director on October 23, 2025 including the findings therein.

### **Amended Certification of Representation**

The undersigned hereby certifies that CWA Local 7076 (CWA) has demonstrated a sufficient basis pursuant to NMAC 11.21.2.38 to authorize amendment of the certification of the bargaining unit of the University of New Mexico Hospital (UNM-H) employees represented by CWA.

The undersigned makes this certification based on the following:

- 1. CWA filed a Petition on August 18, 2025 (PELRB Case No. 325-25), requesting amendment of the Certification of the unit of UNM-H employees represented by CWA, to accrete all full- and part-time PARKING ATTENDANTS (a.k.a. ATTENDANT PARKING).
- 2. On August 18, 2025, the Board's Executive Director determined that the Petition was facially valid and sent notice of the Petition requesting each Party's statement of their positions, which were timely provided.
- 3. A Status and Scheduling Conference was held on September 9, 2025, where it was determined that the Petition does not raise a question concerning representation. It was further determined that the Petition presents sufficient facts to establish that the petitioned-for position, which constitutes less than 10 percent of the number of employees in the existing bargaining unit, shares a community of interest with those in the existing bargaining unit, provided no other labor organization desired to represent the petitioned-for position.
- 4. A Notice of Filing of Petition was posted from September 18, 2025 through October 2, 2025, with a deadline to file any Petitions for Intervention by October 2, 2025. No Petitions for Intervention were filed in this matter.
- 5. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect its current description as follows:
