⁷ This included two cases filed against local boards. One case was filed against the Gallup-McKinley School District's Local Labor Board (along with the School District, see Note 7, *supra*), and the other case was filed against the Northern NM College Labor Relations Board. In both matters, the claims against the Local Board were dismissed by the Hearing Examiner for lack of jurisdiction under Sections 19 and 20 of PEBA. See Cases 103-07 and 155-07.
