ORDER

THIS MATTER comes before the Public Employee Labor Relations Board at its regularly scheduled meeting on March 18, 2026, upon a Petition by the members of the bargaining unit to change their national affiliation. Pursuant to 11.21.3.25, after giving all parties notice and an opportunity to submit their views and receiving no objection, the Executive Director issued an Amended Certification on March 13, 2026, indicating the change. Upon review of the submissions and no one appearing in opposition to the Amended Certification, the Board, by unanimous vote, hereby affirms and ratifies the Amended Certification of Representation issued by the Executive Director on March 13, 2026, including the findings therein.



Amended Certification of Representation

The undersigned hereby certifies that District 1199NM, National Union of Hospital and Health Care Employees [Union], has demonstrated a sufficient basis pursuant to NMAC 11.21.2.35 to compel amendment of the certification of the bargaining unit with regard to the University of New Mexico Hospital [Employer] employees represented by the Union.

The undersigned makes this certification based on the following:

1. Union filed a Petition on February 9, 2026 (PELRB 304-26), requesting amendment of the Certification of the unit of Security employees represented by LiUNA Local 16 Laborers International Union of North America stating that the employees in the unit had voted to change their affiliation to District 1199NM, National Union of Hospital and Health Care Employees. On February 20, 2026, the Board's Alternate Hearing Examiner determined that the Petition was facially valid. Pursuant to NMAC 11.21.2.35, all parties were given an opportunity to express their views on the change of affiliation. No objections to the change were transmitted to PELRB staff.
2. The Petition does not raise a question concerning representation and it presents sufficient facts to show the amendment should be made. Accordingly, certification of the bargaining unit shall be, and hereby is, amended to reflect the change in affiliation of the Security bargaining unit at University of New Mexico Hospital comprised of the following positions, which shall now be represented by District 1199NM, National Union of Hospital and Health Care Employees:

**Aide Security Officers
Parking Enforcement Officers
Security Officers**
